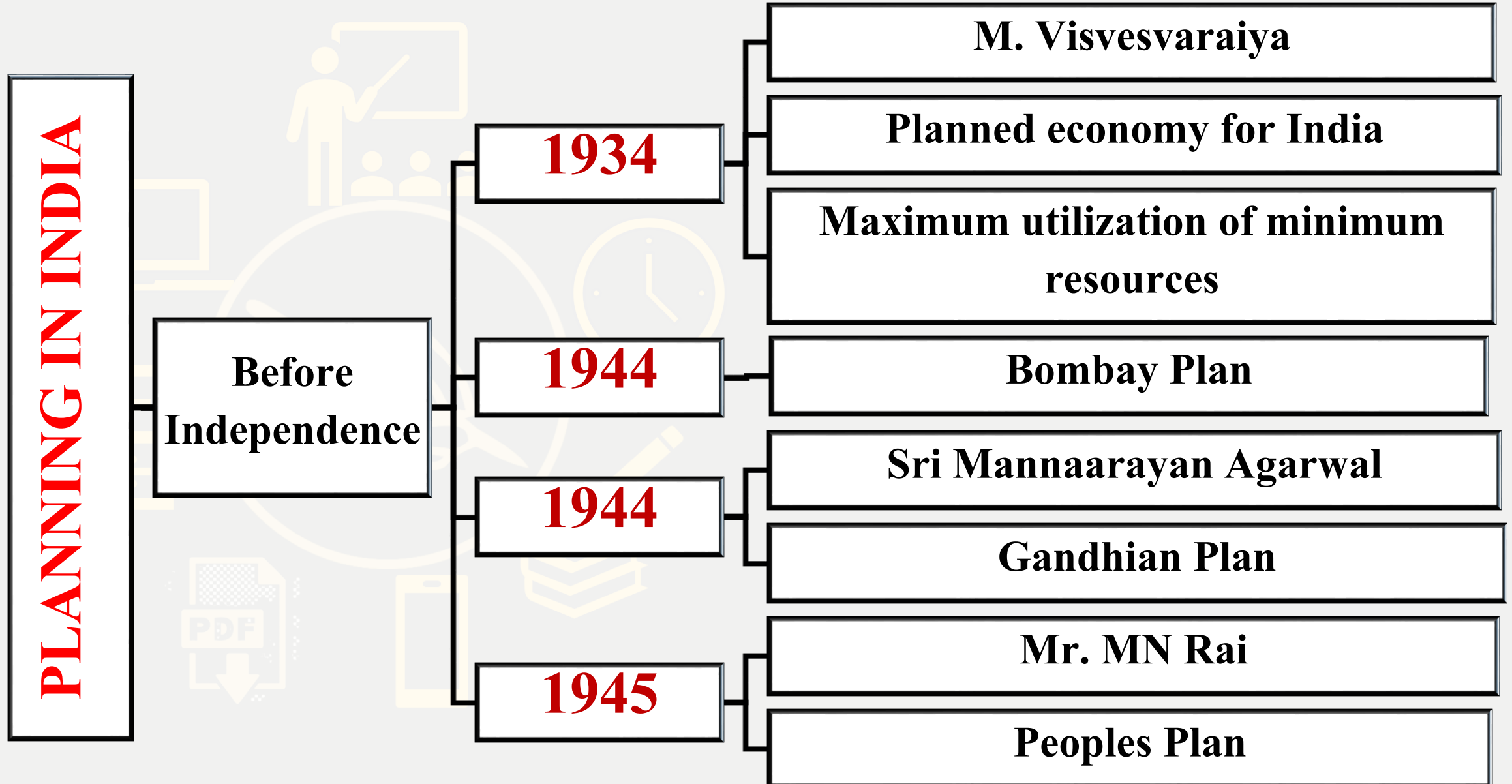

Formed – 6 Aug 1952

Chairman – Prime Minister of India

It is the apex body for decision making and deliberations on development matters in India



1ST FIVE YEAR PLAN - 1951-1956

- Development of agriculture , irrigation and power

12TH FIVE YEAR PLAN (2012 To 2017)

- Tagline- Faster, sustainable and more inclusive growth.
- 12TH Five year plan focuses mainly on Infrastructure.
- Infrastructure will be completed in India through PPP (Public Private Partnership) model.
