



SBI lifts GDP growth view to 9.3%-9.6%

ARTICLE

Economists at the State Bank of India (SBI) have upgraded their GDP growth **projection** for this fiscal to a 9.3% to 9.6% range, from 8.5%-9% forecast earlier, **citing** an improved pace of vaccination and lower incidence of COVID-19 cases in the country. Referring to 41 **high-frequency indicators** factored into their 'Nowcasting' model, the economists have **pegged** second-quarter growth at 8.1%, with an **upward bias**. Official estimates for the July_September period are expected at the end of the month.

India's GDP had grown 20.1% in the April to June quarter, compared with a 24.4% **contraction** in the year-earlier period. The second quarter of 2020-21 saw GDP contract by 7.9%.

SBI's second-quarter estimate is faster than the 7.9% pace projected by the Reserve Bank of India (RBI). The central bank has **estimated** that the economy would grow 9.5% in 2021-22.

“The full year GDP growth is now revised upwards to 9.3%-9.6% from our earlier estimate of 8.5-9.0%. With this the real GDP will be around ₹2.4 lakh crore more than the 2019-20 real GDP of ₹145.69 lakh crore,” SBI group chief economic adviser Soumya Kanti Ghosh said, **stressing** that this would take the economy 1.5% to 1.7% above pre-pandemic levels by March 2022.

India recorded only 11% increase in cases during this quarter which is the second lowest among top 15 most affected countries,” he wrote in the bank’s research report.

“India’s projected 8.1% growth rate in Q2 is the highest growth across all economies. The average GDP growth of 28 selected economies has decelerated to 4.5% in the same quarter as against 12.1% (in the previous quarter),” he pointed out.
