

  FISCAL DEFICIT IS THE DIFFERENCE BETWEEN THE TOTAL REVENUE AND TOTAL EXPENDITURE OF A GOVERNMENT IN A FINANCIAL YEAR. IT ARISES WHEN THE EXPENDITURE OF A GOVERNMENT IS MORE THAN THE REVENUE GENERATED BY THE GOVERNMENT IN A GIVEN FISCAL YEAR.


